Technical Characteristics

These wipes are being classified according to ADR as UN3175/UN1170. This means solids containing flammable liquid.

IPS SatWipes with Ethanol 70% are approved by the Danish Ministry of Food, Agriculture and Fisheries with J.nr. 2016-29-7105-00164/MAKIR and can therefore be used as a surface disinfectant for food processing and production facilities, dairy production facilities and on fishing vessels with storage of fish for more than 24 hours, in accordance to § 2 no. 1 of the decree no. 134 of 11/02/2013 regarding approval of disinfectants and antiseptics in food establishments etc.

Dispensation has been giving for rinse with water afterwards.

Sontara® 9948 / 9960 has Food Contact Clearance and is colored Turquoise / White.
